MAJOR AND MINOR MANAGERS/COACHES: Are **REQUIRED** to provide umpires, as necessary, for VCLL Farm Division. It is my responsibility to become familiar with the Farm playing rules and regulations, and to show up to umpire scheduled Farm games. _____ (Initial)

MAJOR AND MINOR MANAGERS: Are responsible to make sure that the scheduled umpiring responsibilities are met. It is my responsibility as a Major or Minor Manager to make sure that proper and appropriate umpires are provided for each Farm game my team is scheduled to umpire. _____ (Initial)

MAJOR AND MINOR MANAGERS: Are **REQUIRED** to provide staffing for the Concession Stand for assigned shifts. It is my responsibility to make sure that staffing is provided for each shift my team is scheduled to work, or I will be suspended for one game. _____ (Initial)

FARM MANAGERS AND COACHES: Are responsible to staff all try-outs if and when required. It is my responsibility as a Farm Manager or Coach to assist in the VCLL league tryouts when scheduled to do so. Failure to do so will result in a written reprimand from VCLL. _____ (Initial)

EQUIPMENT: I **SHALL** return **ALL** VCLL Team equipment to the VCLL Equipment Manager **NO LATER** than **TWO** weeks after my team's final game. **ALL** equipment **WILL** be returned in a clean and orderly manner. _____ (Initial)

ALL MANAGERS/COACHES: **SHALL** actively support the VCLL by full Participation in/during the following; 1) Annual Fund Raiser, 2) Snack Bar Duties, 3) Picture Day, 4) Opening Day Ceremonies. I understand these activities provide financial support to the VCLL in its effort to minimize expenses. _____ (Initial)
