I hereby irrevocably authorize TNC (Town 'N Country Baseball) to edit, alter, copy, exhibit, publish, or broadcast mine or my family's Likeness and remarks at any time by means of any media, including print, still photograph, video presentations, television, radio and satellite transmissions or rebroadcasts, news bulletins, mailers, billboards or signs, brochures, website placements, email blasts, podcasts, webcasts, social media, Internet or other digital delivery or publications. I understand that there is no time limit on the validity of this authorization and release nor any geographic limitation on where these materials may be distributed. I also understand that stats may be reviewed, discussed and/or posted with others and on TNC (Town 'N Country Baseball) websites and provide my consent, authorization and release to do so.
