DASC is a volunteer-run organization. A Volunteer Credit Program has been implemented to encourage all our DASC families to participate in the work of the club. By distributing the workload, we can keep DASC running smoothly. Our most valuable resource is the range of experience our volunteers have. By working together, we can support and build DASC, and can help keep our players' registration fees low.

Volunteer Credit Rules

PLAYER CAN ONLY DEDUCT ONE CREDIT PER REGISTRATION FEE.

CREDIT CAN ONLY BE USED FOR U6/U8, REC, TRAVEL OR GOALKEEPER ACADEMY REGISTRATION.

CREDIT CANNOT BE USED FOR ADDITIONAL TRAINING, INCLUDING SUMMER & WINTER.

DASC VOLUNTEER CAN EARN MULTIPLE CREDITS, FOR MULTIPLE PLAYERS.

DASC VOLUNTEER MUST IDENTIFY PLAYER THAT THE CREDIT IS FOR PRIOR TO WORK, DURING SIGN UP. CREDIT IS TRACKED BY PLAYER NAME.

CREDIT CAN BE EARNED BY ANY PLAYER'S FAMILY MEMBER OR GUARDIAN (INCLUDING GRANDPARENT, SIBLING IF OVER AGE OF 16, ETC.)

CREDIT CANNOT BE EARNED BY A NON-FAMILY MEMBER.

CREDIT CANNOT BE PARTIALLY EARNED OR REDEEMED. VOLUNTEER FORFEITS ANY PARTIAL CREDITS AT THE END OF EACH SEASON.

CREDIT EXPIRES IN ONE YEAR.

CREDIT HAS NO CASH VALUE.

CREDIT CAN ONLY BE REDEEMED ONLINE, DURING THE REGISTRATION PAYMENT. (NO REFUNDS OR ACCOUNT ADJUSTMENTS CAN BE DONE IF CREDIT ISN'T ENTERED CORRECTLY DURING REGISTRATION.)

VOLUNTEER TASKS ARE PRE-APPROVED BY THE BOARD.

VOLUNTEER TASKS MUST BE REPORTED TO THE DASC TREASURER WITHIN 30 DAYS OF COMPLETION.

DASC TREASURER WILL PROVIDE CREDIT REDEMPTION INSTRUCTIONS AT THE END OF SPRING AND FALL SEASONS.

IF VOLUNTEER HAS A DISPUTE, VOLUNTEER MUST EMAIL A CLEAR APPEAL TO THE DASC TREASURER NO LATER THAN NOV 15th FOR THE FALL SEASON AND JUN 15th FOR THE SPRING SEASON.

IF A VOLUNTEER RESIGNS AS BOARD MEMBER, ASSISTANT MANAGER, TEAM MANAGER BEFORE THE END OF THE SEASON, THAT CREDIT WILL BE VOID.
