



Norridge / Harwood Heights Little League Sponsorship Agreement

This agreement between the Norridge / Harwood Heights Little League (hereinafter, “Local Little League”) and

(hereinafter, “Sponsor”) is for the 2018 season.

Sponsorship of the Local Little League must be, for the Sponsor, out of a sense of duty to help the community. While Sponsorship does afford some benefits (detailed below), the higher purpose is to help the Local Little League impart the values of teamwork, sportsmanship, and fair play to the children of the community, so that they may someday use these values in becoming good citizens.

Sponsorship of the Local Little League does not permit the Sponsor to have any rights or responsibilities in the operation of the Local Little League or any team in the Local Little League, nor does the Sponsor have any rights or responsibilities in the selection of managers, coaches or players for any team in the Local Little League. Nothing herein shall make us partners or joint ventures. The Sponsor and the Local Little League are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with the Local Little League ONLY, and NOT with Little League Baseball and Softball, the organization. Use of the marks of logos of Little League Baseball and Softball by any local sponsor is prohibited, unless permission is expressly granted in writing by Little League Baseball, Incorporated.

The Local Little League agrees to provide the following benefits in exchange for the sponsorship commitment:

\$250 - Silver Sponsorship Package

- Placement of Sponsor logo on “SPONSORS” page of Local Little League website, with direct link to Sponsor website.
- Placement of Sponsor logo on sponsor scroll of each page on Local Little League website, with direct link to Sponsor website.
- Special Recognition at Opening Day Celebration
- Sponsorship plaque with team photo.
- Silk screen placement of sponsor logo on sleeve of baseball or softball team

\$500 - Gold Sponsorship Package

- Same benefits as Silver Sponsorship with the addition of:
 - 2 complimentary tickets to our end of season banquet
 - Sponsors logo displayed at concession stand

All Sponsorships are for a period of 1 year from the start of the season. Some restrictions apply to all Logos used (Size, content, etc.). A league officer will contact you to go over logo restrictions and assist in design, if needed.
