Headgear is required. PIAA rules will govern except: all bouts will consist of three periods of 2-1-1 minutes, overtime-1-:30, if needed. Wrestlers must be able to provide a copy of their birth certificate at the Area III tournament and the PA State Championships. Must wrestle in the weight class entered – no changes or substitutions. Entrants not making weight will be scratched. A wrestler cannot wrestle outside of his/her age group and can only enter one weight class.
