



## **WAIVER AND RELEASE OF LIABILITY AGREEMENT FOR MINOR PARTICIPANTS**

### **READ BEFORE SIGNING:**

I, the undersigned parent/guardian, and in consideration of my child/ward being allowed to participate in any way in the MARTINEZ-EVANS LITTLE LEAGUE, INC. athletics/sports programs and/or related events and activities, do hereby acknowledge, appreciate, and agree that:

1. The risk of injury and/or illness to my child/ward resulting from his/her participation in these programs, events, and/or activities is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist;
2. The risk to have contact with individuals who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19/Coronavirus and/or other medical conditions, diseases, viruses, or maladies does exist, and it is impossible to eliminate the risk that my child/ward could be exposed to and/or become infected through contact with or close proximity to an individual with a communicable disease, medical condition, virus, or other malady;
3. I hereby EXPRESSLY, WILLINGLY, AND VOLUNTARILY ASSUME ALL SUCH RISKS, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my child/ward's participation;
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If I observe any unusual and/or significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from participation and bring such to the attention of the nearest official immediately. I also acknowledge that MARTINEZ-EVANS LITTLE LEAGUE, INC. retains the right to refuse my child's participation if any volunteer, official, and/or board member suspects my child is at risk of and/or exposed to any injury and/or illness;

I hereby, for myself and my child/ward and on behalf of my/our heirs, assigns, administrators, executors, personal representatives and next of kin, FOREVER HOLD HARMLESS, INDEMNIFY, AND COVENANT NOT TO SUE MARTINEZ-EVANS LITTLE LEAGUE, INC., its officers, directors, board members, officials, agents, employees, volunteers, sponsoring agencies, sponsors, advertisers, other participants, owners and lessors of premises used to conduct such programs, events and activities ("Releasees"), with respect to any and all injury, illness, disability, death, or loss or damage to person or property incident to my child/ward's involvement and/or participation in these programs, events and activities, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.

I hereby, for myself and my child/ward and on behalf of my/our heirs, assigns, administrators, executors, personal representatives and next of kin, FOREVER WAIVE, RELEASE AND DISCHARGE ANY AND ALL RIGHTS, DEMANDS, CLAIMS, AND/OR CAUSES OF ACTION FOR ANY AND ALL DAMAGES OR LOSSES, WHETHER MONETARY OR OTHERWISE COMPENSATORY AGAINST MARTINEZ-EVANS LITTLE LEAGUE, INC.; its officers, directors, board members, officials, agents, employees, volunteers, sponsoring agencies, sponsors, advertisers, other participants, owners and lessors of premises used to conduct such programs, events and activities (“Releasees”) that may result from my child/ward’s involvement and/or participation.
  
7. I, the undersigned parent/guardian, assert that I have explained to my child/ward the risks of the activities, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement.

**I, FOR MYSELF AND MY CHILD/WARD, HAVE READ THIS WAIVER AND RELEASE OF LIABILITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
