



2019-2020 AREA G GUIDELINES

Area G League will be conducted in accordance with FIFA Laws of the Game, AYSO National and Section One Rules and Regulations with the following clarifications, modifications and additions. These guidelines have been developed by representatives of all Regions in Area G and Area G staff. All participants must abide by any additional requirements or restrictions adopted by their home Region.

I. REGION ELIGIBILITY AND PARTICIPATION

- a. All Regions in Area G may participate.
- b. Regions must meet the minimum requirement as a Region to participate.
- c. Teams from other Areas will be accepted with approval of Area G Regions.
- d. Region teams not participating in Area League play will not be eligible to participate in Area playoffs.
- e. Teams shall be formed no later than August 5th. (Upper Division)
- f. No player shall be added to a team after the 1st. league game unless the team drops below 14 players. (Upper Division)
- g. Any players added after the 3rd league game must be approved by Area League Coordinator or Area G Director. (Upper Division)
- h. To be eligible for Area playoffs, player must participate in at least 50% of scheduled games for his/her team.
- i. Special circumstances shall be reviewed by Area G Director.

II. TEAM FORMATION

Per National Rules & Regulations Article II.D, expanded roster sizes require prior approval of AD

III. COACHES

- a. To participate in Area G, team coaches (head and assistant) must be registered with AYSO National and certified at the appropriate coach level. Coaches and assistant must be listed on Blue Sombrero roster prior to area playoff meeting.
- b. Coaches must have taken AYSO Safe Haven and Concussion Awareness Training available at www.aysou.org.
- c. A qualified coach must always be present with the team along with signed player registration form, e-signature verification page necessary.
- d. Coaches shall be responsible for behavior of their spectators and shall promote positive atmosphere.

IV. UNIFORMS

- a. There will be strict observance of the AYSO uniform dress code. All team participants will be uniformed in the same, matching color/style jersey, shorts, and socks without exception.
- b. Shin guards must be worn, completely under the issued uniform sock.
- c. Any tape used must match uniform socks or be used inside the socks.
- d. No jewelry, including ear studs, will be allowed.
- e. No player with a cast or splint may participate.
- f. No headgear other than soft sweatbands will be allowed.
- g. If any player is found to be in improper uniform, it must be corrected before the offending player(s) shall be allowed to play. Decisions of the Playoff Official regarding uniforms are final and may not be appealed. In case of inclement weather, garments may be worn under uniforms provided they are all of the same style, length, and color and do not constitute a color conflict.
- h. In case of conflicting colors, if a team has alternate jerseys, it shall be allowed to change; otherwise, both teams shall wear scrimmage vests provided by the Region, Area or Section hosting the competition.
- i. Long fingernails may be considered a safety hazard requiring cutting or taping.
- j. Players shall not smoke when wearing AYSO uniform or while in the vicinity of an AYSO function.
- k. It shall be the responsibility of the individual players to abide by the uniform requirements.
- l. Violation should be reported to the Site Official or referee to be noted on the game card.

V. REFEREES AND OFFICIATING (misconduct & discipline)

- a. Area Referee Administrator shall insure that an impartial team of at least 2 referees is scheduled for all games, during playoffs.
- b. Center Referee must be an advanced or National level Referee certification. In the event badge level is unavailable prior experienced Intermediate may step in with preauthorization from ARA and AD. Assistant Referees must be experienced intermediate level or above and approved by ARA and AD. No Regional Referee will be allowed to Referee upper division without prior authorization from ARA and AD. In the event a Regional Referee is approved to AR, center Referee must be Advanced or above level certification. No club lines men are allowed to stand in

for any Referee. The home team will be required to forfeit the match in the event there are not properly certified referees on the match, match can still be played.

- c. Referee shall allow a grace period of fifteen (15) minutes before canceling the game. A team not ready at the time shall forfeit the game. If a team does not show for a scheduled game, its opponent will be awarded a 1-0 victory by forfeit. The Area Director may impose additional sanctions if the forfeiting team gains an advantage by the forfeit.
- d. **(Upper Division)** There will be a mandatory cooling off period coaches are required to remove a player receiving a Caution (yellow card) from the game for 3 minutes. A coach may use his/her own discretion if more time is needed, **coach can also substitute that player out or play short until the 3 minutes have passed.** If a team falls below 7 players, game will still go on and not be suspended.
- e. **(Upper Division)** A player needing assistance on the field, except for the goalkeeper, shall leave the game for a period of 2 minutes. Team may substitute or play short. Injured player may return to the field of play with referee permission.
- f. **(Lower Division)** A Coach may use his/her own discretion to either substitute a player receiving a Caution (yellow Card) or remove the player from the field to allow for temporary cooling off period by playing short. If the cautioned player is substituted, they may not return to the field until the next substitution period. The Cautioned player may return to the field with referee permission only if the coach played short during this cooling off period.
- g. **(Lower Division)** A player requiring assistance on the field, except for goal keeper, shall leave the field of play. A coach may choose to substitute an injured player until the next substitution period or play short while player injury is being assessed. Upon assessment of player and with referee permission, a player may re-enter the field only if the coach played short.
- h. Unless the referee specifies otherwise, non-participating players, substitutes, coaches and other spectators may not be allowed on the field behind the halfway line, or off the field behind the penalty area. They shall not interfere in any way with participating players or referees.
- i. **"Spectators shall not be allowed behind the goal lines, with the exception of photographers who have received authorization from the referee, and who shall remain quiet and sufficiently back from the goal lines."**
- j. When cautioning a coach, a referee will display a yellow card, when a coach is ejected the referee will display a red card.
- k. Regional disciplinary action, including red card and yellow cards (if applicable), shall carry over.
- l. Any participant who is SENT OFF (red card) before-during-or after the game, will be suspended for the minimum of the participant's next scheduled game.
- m. Further participation in Area or Section Playoffs will be subject to review by Area officials.
- n. Any participant who is SENT OFF for Violent Conduct shall be ineligible for further participation in, or attendance at, Area and/or Section Playoffs.
- o. Any participant who instigates a physical or verbal confrontation shall be suspended from Area playoffs and will be ineligible for participation in, or attendance at, Section Playoffs.
- p. Any coach or player receiving a third Caution shall have an automatic 1 game suspension and possible appearance before a Review Panel.
- q. Coaches have the responsibility for monitoring the number of cards received by individual players and acting accordingly, even without official notification.

- r. If time permits, a League Official shall send team Coach a warning following the second yellow card received by a player.
- s. The Review Panel shall consist of the Assistant Area Director, as Chairperson, and the following representatives: Area Coach Administrator, Area Referee Administrator, neutral Regional Commissioner, and a neutral player or parent representative.
- t. **No Protest shall be allowed!!!!**

VI. FIELDS

- a. Home Region shall insure that the field is properly set-up and taken down, including corner flags. Field lines, including required 10-yard coaching restriction lines, should be clearly visible. (Upper Division)
- b. All fields should have an assistant referee lane parallel to the touchline; a minimum of 3 feet outside of touchline, between the 2 penalty areas.
- c. Coach box should be behind this area. Recommended minimum field size; 60 x110 yards.

VII. GAMES

- a. Teams must report for all scheduled games unless otherwise notified by a Region or League official. Cancellations or “no shows” may result in removal from the League.
- b. Visiting team coaches, players and spectators shall remain on opposite side of field unless otherwise advised due to field restrictions. There shall be no cross coaching.
- c. Both teams shall remain in their field half not covered by the Assistant Referee.
- d. A Site Official shall be at all games. He/she shall assist the referee in uniform inspection and ensure that player registration forms are available.
- e. Site Official shall collect substitution sheets from each team, game cards and referee game report, at end of game. (Upper Division)
- f. Substitution of players shall be allowed at any stoppage of play, with or without possession, at the discretion of the referee.
- g. Players entering game must be recognized by referee prior to entry onto field.
- h. All players are only required to play half the time they are on the field and available to play their scheduled game. Example: If a player arrives at halftime, they must play 1/4 of game.
- i. Each team must maintain the official Substitution Record Sheet, during the game, documenting the minutes each player is out of the game.
- j. Coaches shall review sheet at half time to ensure all players are receiving required playing time. Sheet shall be signed and given to Site Official at end of game.
- k. Random monitoring of free substitution shall be conducted by Area G League officials.
- l. Each Region shall be required to submit a comparison substitution sheet for a minimum of 1 game for each of their teams.

- m. Area G League Coordinator shall be notified within 48 hours of any suspected violation of substitution.

VIII. STANDINGS (league play)

- a. Standing in league play, points shall be awarded as follows:
- Win – 3 points
 - Tie – 1 point
 - Loss – 0 points
 - Potential point deductions will be assigned as follows: Send Off = 2 points, Caution = 1 point. A team shall lose 1 point in league standings when 10 points are accrued and 1 point for each additional 5 points thereafter.
- b. Tie breakers for standings at the conclusion of league play shall be as follows:
- Cards issued (yellow and red) for coaches and players
 - Head-to-head play (outcome of the game involving the tied teams)
 - Goal differential: goals scored, less goals allowed, maximum differential of three (3) goals per game. (All league games not including practice games, and not limited to head-to-head games)
 - Coin toss

IX. PLAYOFFS

1. ALL DIVISIONS

- a. One (1) hour prior to your game time, coaches shall present themselves along with the entire team to the official at the check-in area. Team line-up cards, rosters, player registration (medical authorization) forms and uniforms will be inspected.
- b. Properly completed lineup cards in uniform number order shall be presented to the official prior to the start of the game and shall include the names of all players, present or not, and an explanation of absences.
- c. Standings for Pool Play
- WIN = 3 points
 - TIE = 1 points
 - LOSS = 0 points
 - FORFEIT = 3 points
 - RED CARD = 2-point deduction for team (includes 2 points for each player, substitute, or coach).
 - YELLOW CARD = 1- point deduction for team
- d. Tie Breakers for standings at the conclusion of playoffs shall be as follows:
- Cards issued (yellow and red) for coaches and players
 - Head-to-head play (outcome of the game involving the tied teams)
 - Goal differential: goals scored, less goals allowed, maximum differential of three (3) goals per game. This applies to all playoff games, not limited to head-to-head.
 - Coin toss

2. UPPER DIVISION 16U & 19U

- a. Referee shall allow 15-minute grace period for teams to have the noted minimum number of players: 16U – 7 players, 19U – 7 players
- b. If the minimum is not available after the grace period, the referee shall note the circumstances on the game card and Area officials shall determine outcome of game. (This should end in a forfeit).
- c. Points accumulated in Area Play will be reset to zero. Suspensions received must still be served, but ay cards issued in Area Playoffs will be used in the area of the Tie-Breaker.
- d. All games will consist of two 30-minute halves.
- e. A Site Official shall be at all games.

3. LOWER DIVISIONS 10U, 12U, 14U

- a. Referee shall allow 15-minute grace period for teams to have the noted minimum number of players: 10U – 5 players, 12U – 7 players, 14U – 7 players
- b. If the minimum is not available after the grace period, the referee shall note the circumstances on the game card and Area officials shall determine outcome of game.
- c. The schedule shall allow for each region to have 2 teams per division participate.
- d. Teams shall be divided into 2 pools. Pool groupings shall be drawn by Area G Regional Commissioners. Draw shall be conducted so that, where possible, Regional teams do not play each other in pool rounds.
- e. All fields should have an assistant referee lane parallel to the touchline; a minimum of 3 feet outside of touchline, between the 2 penalty areas.
- f. Coach box should be behind this area. Recommended minimum field size
- g. Teams must report for all scheduled games unless otherwise notified by a Region or League official. Cancellations or “no shows” may result in a regions participation of a second team in said division.
- h. Visiting team coaches, players and spectators shall remain on opposite side of field unless otherwise advised due to field restrictions. There shall be no cross coaching.
- i. Both teams shall remain in their field half not covered by the Assistant Referee.
- j. First team on the schedule shall be the home team and shall set up on the North or East side of field; coaches, players and spectators shall remain on that side. (Area Playoffs)
- k. Pool match times will be as follows...10U and 12U-20-minute halves, 14U-25-minute halves. (Semi-final or final will be full length match if time allows) AD will determine time allotted.
- l. A Site Official shall be at all games.
