23rd Annual Colorado River Open Invitational Tournament Team Invitation

Hello, Coaches!

AYSO Region 397 is proud to invite your team to the 23rd Annual AYSO Colorado River Open Invitational Tournament

- Scope: AYSO Open Invitational – open to AYSO teams from all Sections and Non AYSO Teams.
- When: Saturday, Sunday, & Monday, **13th through 15th February, 2021**; Rain Dates- **February 20-21, 2021**.
- Where: The tournament will be held at the Rotary Park Soccer Fields at 2315 Balboa Dr, Bullhead City, AZ. No pets are allowed at fields.
- Who: AYSO and Non-AYSO boys and girls teams in age divisions: 19-U, 16-U (11v11) 18 players max. 14-U (11v11) 15 players max. 12-U (9v9) 12 players max and 10-U (7v7) 10 players max. All players must have been registered to play in their organizations' most recent primary season. Guest players will be allowed (3 maximum per team). Co-ed teams will be accepted in boys' divisions only. Teams that normally have larger roster size can request advance permission from CRIT staff to bring their full roster.
- What: Pool play tournament. Each team will be guaranteed 4 games in pool play. The top teams will advance to the medal round on Monday. All games will be as follows: (80 min. for 19-U/16-U, 70 min. for 14-U, 60 min for 12-U, and 50 min for 10-U).
- Why: This Tournament is being conducted as a fundraiser by Region 397 to raise funds for Field Development, Equipment, & Maintenance, and to provide Scholarship funds for youths in Region 397.
- Awards: Each team member and coaches (2) will receive a t-shirt and tournament pin. All players on the 1st through 4th place teams will receive a medal. The first place coach will receive a trophy.
- Entry Fee, Refunds: \$495 for 19-U & 16-U, \$425 for 14-U, \$395 for 12-U, and \$395 for 10-U. A full refund will be issued if tournament is canceled and cannot be rescheduled. If a team withdraws 30 or more days before the tournament, a full refund is given. Within 30 days of the tournament, no refund is provided unless a replacement team is found.
- Referee Deposit, Refunds: \$250, refundable within 14 days after the tournament, if referee assignments have been completed. Each team is asked to provide a credentialed and qualified 3-person referee team to cover 4 games during the tournament.
- Rules: A full set of tournament rules are posted on the tournament website.
- Acceptance: The application deadline is **January 18, 2021**. All teams will be notified within 48 hrs. after the application deadline or receipt of application (whichever is latest) as to their status. Teams that are not accepted will be given the option to have their complete application returned within 48 hours of request or to be placed on the waiting list.
- How: Team entry applications and all necessary forms are available on the tournament website. Please send 1 Region / Organization check to cover both the Team Entry and Referee fees, along with the tournament application, referee information form, and team roster to the Tournament Registrar address below. Regional Commissioner or Organization President/Registrar must sign application and team roster. Appropriate referee administrator must sign referee information form. See referee form for details.
