Academy

Pool training within the Academy will be open to all age groups (U4-U 12). Training date/time is still being discussed to try to pinpoint the appropriate time for the U4 age group.

One option is to train prior to games if another time is too difficult to schedule. Concerns discussed regarding losing interest because they are tired if they practice right before the game. Will re-evaluate attendance over time and come up with works best for the majority of kids.

Registration

Registration should open on our website July 1 for Division III. The MSA 2014-2015 year ends June 30. The 2015-2016 year begins July 1, 2015 and runs through June 30, 2016.

Street Soccer

Street soccer can no longer be played at the Bovina Complex due to insurance with MSA expiring on June 30.

Until WCPR says Street Soccer does not have to be insured, then Street Soccer cannot continue at the complex until insurance is obtained. VSO could continue to provide insurance through MSA however there is currently no acceptable oversight plan and VSO has no way to ensure all players are registered thereby having appropriate insurance coverage.

County has made complaints regarding lights left on and possible trespassing.

It was decided that Street Soccer is separate and unique from VSO. It will be taken off registration portion of webpage and removed from banner on website.

VSO and Cannon registered youth can play on Sunday but will be renamed to something such as youth free play.

Concession Stand

Perry Boyd from TBeauxs won't be doing concession stand during Rec games. They may return for tournaments.

Wioletta Malej has expressed interest in running the concession stand and will have a proposal at next meeting.

Concession Manager will research the Health Department's "Serve Safe" online certification to serve nachos and hotdogs. VSO currently cannot prepare food as there is no separate handwashing sink.
