## Advertising Banner Agreement

This agreement is between Greece Little League, Inc. ("the League") and <INSERT SPONSOR NAME/BUSINESS ENTITY> ("the Sponsor") and outlines the Terms and Conditions with the purchase of an advertising banner described in the "Home Run" level of sponsorship by Greece Little League.

### The Sponsor agrees to:

Purchase one (1) advertising banner with the dimensions described to be six (6) feet long and three (3) feet wide. The purchase will include:

The Sponsor will remit payment of one thousand two hundred eighty five (\$1,285) or an annual payment as described below:

The first year of the agreement will be a payment to the League of four hundred twenty five dollars (\$425)

The second through fifth year of the agreement will be a payment to the League of two hundred fifty dollars (\$250) annual

Annual commitments will be invoiced by the League by Jan 31st and and be remitted by May 1 of each year of the duration of the agreement unless negotiated otherwise.

Provide the League with the appropriate graphics information for the creation of the banner unless the banner is provided by the Sponsor.

This agreement will last for a duration of five (5) years beginning with the date this agreement is signed, and concluding on September 30<sup>th</sup> of the fifth consecutive year thereafter.

### The League agrees to:

Provide advertising space at the Greece Little League Complex by affixing the Sponsor's advertising banner (described above) to the outfield fence of one of the eight (8) fields or agreed upon space on the property.

Consider the Sponsor's request for a particular field if one is made at the time of the initiation of this agreement.

Provide all first-time production and installation costs of the Sponsor's advertising banner. Any subsequent production, graphics, editorial changes and/or installation costs are to be borne by the Sponsor.

Permanently display the Sponsor's banner for each year of the duration of this agreement no later than May 1 (earlier if weather permits) and until September 30. Secure and store the Sponsor's banner when the Greece Little League's Complex is closed for the season.

**Provide maintenance and necessary repairs to the Sponsor's banner due to vandalism or damage beyond normal weathering and wear and tear.  
Remit to the sponsor the pro-rated balance of the agreement if, at any time, the League is unable to display the Sponsor's banner for any reason beyond its control.  
Provide the Sponsor with the banner upon request of the Sponsor at the end of the period of time specified by the duration of this agreement.  
Provide the Sponsor with recognition the League's website, at the Greece Little League complex or other appropriate communication to the league participants or public.**
