Important Notice – *A statement from the District Administrator must accompany this request.* This waiver does not take effect until this form (completed, notarized, received and filed at the Regional Headquarters, along with the DA's statement) is approved in writing by the Regional Headquarters.

Instructions for Completing Regulation II Waiver

1. Parent contacts (email is acceptable) the League President for the league in which the child resides to request support for child to play in Rowayton Little League

The letter/email request needs to state the compelling reasons why the waiver is justified. This letter MUST include the following:

Name of player

Address of player

Birth Date of Player

Compelling reason why this waiver should be granted (i.e. child attends Rowayton School, etc.)

2. If the League President approves the request, the Parent needs to complete the attached form, have the Parent's signature notarized and deliver the letter to Roger Knight, Rowayton Little League President. Please note that any player who plays in a league through a residency waiver may only play in the regular season and is prohibited from playing in all-star play.

3. The Rowayton Little League President will deliver the notarized waiver request to the appropriate League President for his/her signature.

4. The CT District 1 Administrator will add his/her recommendation to the request, and send the form on to the Regional Office of Little League International.

5. The Regional Office will then add their recommendation to the request and forward the request to the Charter Committee in Williamsport PA.

6. If Williamsport approves the request, the boy/girl will play in the requested league for that year only.

Example:

If the player lives in Norwalk-2nd Taxing District and wants to play in Rowayton-Sixth Taxing District, the initial E-mail request should be sent to Paul Grillo, Norwalk Little League President. If Paul approves, the Parent fills out the form, has it notarized and delivers it to Roger Knight. Roger signs it, delivers it to Paul for signature and the executed form is given to Scott Miller, CT District 1 Administrator.
