**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,
AND INDEMNITY AGREEMENT (“AGREEMENT”)**

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 and other infectious and/or communicable diseases

INTERNATIONALS SOCCER CLUB, LLC (“Club”) is following current guidelines from state and local officials regarding putting in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or your child(ren), or those parties related to you will not become infected with COVID-19.

In consideration of being permitted to participate in any Club event or activity including, but not limited to, practices, games, programs, meetings and related events and activities, the undersigned understands, acknowledges and agrees that:

1. Participation in such events or activities by my child and or/myself involves the possible exposure to and illness from infectious and/or communicable diseases including, but not limited to, COVID-19, MRSA, influenza, and other infectious or communicable diseases. While adherence to particular rules and requirements may reduce the risk of possible exposure, the risk of personal injury, serious illness, permanent disability, and death remains; and
2. On behalf of my child and/or myself, I knowingly and freely ASSUME ALL SUCH RISKS, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my participation; and
3. I understand that the risk of becoming exposed to or infected by COVID-19 and/or other infectious and/or communicable diseases during Club activities, or being at locations where Club activities are held, may from result the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, contractors, volunteers, and program participants and their families; and
4. On behalf of my child and or/myself, I agree to comply with all rules, regulations or conditions established by the Club and the State of Ohio for participation in such events or activities. If, however, I observe any violation of the rules, regulation or conditions established by the Club or the State of Ohio during my presence or participation, I shall remove myself from participation and immediately bring such matter to the attention of the Club; and
5. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) and/or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my or my child(ren)'s participation in Club activities or being present at Club activity locations (“Claims”). On my behalf, and/or on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, Club activity location owners, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its officers, officials, agents, employees, Club Members, Leagues and Associations, other participants, sponsoring agencies, sponsors, advertisers, representatives, and if applicable, owners and lessors of premises used to conduct the event or activity in which I participate or am present, whether a infection occurs before, during, or after participation in any Club activity. Further, I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio or any other state in which myself or my/our child may participate in any event or activity described herein, and that if any portion of this release is determined to be invalid, it is agreed that the remaining provisions of this release shall continue in full force and effect.

Finally, I further state that I have fully and carefully read the above release OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
