The sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: "Sponsor of a team in the Belmont Heights Little League." Sponsorship does **NOT** give the sponsor the right to use the word "official" in connection with its Sponsorship. Any reference to the sponsorship under this agreement must make it clear that the sponsorship is with a team or teams in the **Belmont Heights Little League** only, and **NOT** for Little League Baseball. Use of the "keystone logo" or any other Logo of Little League Baseball is prohibited, unless little expressly grants permission in writing League Baseball International Headquarters.
