

## **CONCESSION STAND POLICY**

In accordance with the "Parent Code of Conduct" agreement everyone acknowledged with their registration form: **Each family must work all assigned concession shifts in the league at our concession stand. A substitute worker must be at least 14 years of age.**

If for some reason you would be unable to work the game you volunteered for, you must find a replacement and/or let the concession stand manager know as soon as possible. You will be expected to reschedule for another game though. **We want to remind all of our members that these positions are volunteer.** We expect all members, fans and players to act in a respectful manner at the stand when ordering or completing their stand time.

**Question:** Are you running a baseball league or a business?

**Answer:** When it comes to the stand we have no choice but to run it like a business. The Greater West Melbourne Little League (GWMLL) operates entirely by members fees, sponsors and concession stand revenue. We receive money from no other entities. The concession stand revenue is a vital part of the GWMLL. All proceeds go to the children.

**Question:** What will happen if I send my teenage child or someone else to work my stand time?

**Answer:** Anyone age 14 and older can work the concession stand, so older siblings and relatives can fill in for you.

**Question:** When should I arrive for my shift?

**Answer:** First time workers should arrive 15 minutes before their shift starts in order to receive instructions on how to operate the concessions.

**Question:** What if an emergency comes up and I am unable to work my scheduled shift?

**Answer:** If you know in advance and are able to switch with another parent on your team please do so. If it is an immediate emergency please notify the Concession Stand Manager / Team Manager as soon as possible.

**Question:** What if I absolutely am incapable of working in the concession stand?

**Answer:** If you would like to "Opt Out" of volunteering, you can provide GWMLL a \$50 check prior to the first game.
