Please read this card carefully. It explains your financial liability to the LJFL in the event you lose or damage equipment on loan from the league for its players. LJFL has supplied the equipment listed on the back of this card in good working order & clean.

I assume full responsibility for insuring that equipment is returned clean and in good working order. Any problems as defined by LJFL found in the equipment upon its return will be subject to charges as detailed on this equipment card.

In the event I do not return the equipment by the final equipment return date (or within 48hrs after I leave or I am dropped from the league*), the full replacement value of the equipment will be charged. The full replacement value of the equipment is \$350. I understand that after the final equipment return date in November, equipment returned may not be accepted at all. If equipment is accepted after the final return date, severe freight and restocking charges will apply. I further understood that the league offices close in November and late returns will not be reconciled until sometime after the offices re-opens in February.

Initial _____ I understand and will inform my child that only LJFL Coaches are permitted to make adjustments to the helmet. Over-inflating or using improper pumps will damage the air-bladder system. I may be responsible for the cost of repairs if I fail to follow this policy and the helmet is damaged.

The practice jersey and mouthpiece are the players to keep. LJFL expects the equipment to be returned in the following manner to avoid charges: The helmet does not have any decals or stickers attached. It has been cleaned thoroughly both inside and out. Hair dye, paint or other foreign materials will constitute a reconditioning charge. The mouthpiece should be removed and disposed of before turning in the helmet. The facemask should not be changed or altered. It should not have been removed and subsequently replaced. There should be no more wear to the facemask than would occur from game conditions. The chinstrap should be returned with the helmet. When washing the game jersey do not use harsh detergent or bleach. Wash inside-out in cold water and drip dry. No alterations or changing of the fabric to the game jersey. The game jersey should be returned clean and folded. Shoulder pads should be cleaned with the straps buckled and not left hanging loosely. The cord should be tied tightly. Game pants should be clean with all protective padding removed. A charge for dirty game pants will be incurred. Protective pads should be removed from pants and/or girdle. The pads should be clean and not torn or cut. Girdles should be washed and clean.
