- Call to order.
- Treasurer: Club is now officially tax-exempt by the IRS. Next step is to present this to NY State to receive a certificate to not pay sales taxes.
- Rec update. Coaches meeting 4/24. Want to bring equipment over to Manlius from bowling alley on Sunday 23rd, at 5PM, please assist if available. Paper vs paperless at coaches meeting. Group agreed to go paperless. Mark to send email to coaches to remind of Meeting on the 24th. Pete to convene Rec committee to decide what attachments should be part of the electronic packet for coaches.
- Filed lining still tentative for 4/26. Chuck Steele not present.
