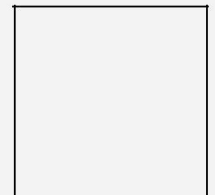

**Guidelines**

1. This form must be completed in full and all signatures must be obtained
2. One acceptable original progress report must be turned in during the time frame specified above and in participant's book prior to game day certification
3. If no progress report is received, the player is ineligible for the remainder of the season.
4. This form and the one progressing progress report must be in book at all times.
5. If progressing progress is received in the designated timeframe the player is eligible for the remainder of the season.
6. If a player is found ineligible and plays, the team and coach shall be subject to penalties as outlined in the National Pop Warner Rule Book.
7. At the end of the designated time period, a League Board member or member of the League Scholastic team must certify eligibility for the rest of the season.
8. The Head Coach and/or Parent/Guardian will be required to come before the PW board if found allowing an ineligible child to participate in any game.
