Dave is suggesting that we need to get on uniform selection and costs asap and define next year's player registration fee. Look for reversible jerseys. Charge minimal extra fee for new uniforms. Scott will acquire quotes for reversible jersey uniforms.

Eric suggested encouraging in-house coaches to do clocks and books, noting some problems, ensuring that of those eligible volunteers that who are able to do clocks and books to do that rather than other jobs.

Eric Rexrode gave a report on the Little Dribblers program. Started with 70 girls and 8 coaches. Suggestion made to use Intermediate School on Sundays exclusively for Little Dribblers. Ended season with 45 girls and lots of favorable comments from parents.
