\_\_\_\_\_ **Initial** I/We understand that if a player /cheerleader has not turned in their birth certificate or they will not be allowed to participate in any activities. I/We understand that if a player /cheerleader has not had their physical examination or they will not be allowed to participate in any activities. Your child must have a current (same calendar year) PHYSICAL EXAMINATION by a licensed physician. The physical examination must be within 60 days prior to the 1st day of practice.

Parents need to notify teams administrator and coach of any prior medical conditions or medications being taken.
