## Terms and Conditions

- Definition:** The term “you,” “yourself,” “your” below refer to person who signed front page usage agreement. The term “PCCBM” refers to Portage Curling Club Board Member.
- Customer acknowledgement:** You acknowledge that the grill you are using is the property of the Portage Curling Club. You further acknowledge that prior to signing this agreement you have read the usage information sheet. Any questions concerning use of grill should be brought to PCCBM prior to pick-up of grill. You are obligated to return the grill to Portage Curling Club in the same condition except for ordinary wear and tear. You agree that you have been properly shown how to use the grill.
- Use of Equipment:** You agree to use the grill only for the purpose for which it was intended. This includes the tools that come with it. You agree not to transfer the grill to any other person without prior approval from PCCBM.
- Responsibility for Equipment:** You agree that you are responsible for the safekeeping of the grill from the time you pick it up until it is returned to the Portage Curling Club. If damages have incurred in any way while you were using it, you agree to be responsible for all damages including parts and labor. If damage is to extensive or grill was stolen, you agree to pay Portage Curling Club the fair market value.
  - Tools included: 3 coal shovels, wire brush, and coal rake.
  - Hitch pin and trailer adjustable stand also included.
  - Value of the grill is estimated to be \$2,000.
  - Lock and key replacement value to be \$40
  - Cleaning charge to be \$80

- Release, indemnification and exclusion:** You agree to assume all risks in the use and operation of grill and everything included and or attached to the grill. You agree that you have complete responsibility of any damages or injury resulting from your use of the grill. You agree that you release the Portage Curling Club from any types of claims described above.
- Return and pick-up:** Return to Portage Curling club at designated point and lock it up.
- Payment and collection costs:** Payment must be made prior to pick-up. You agree to pay any other charges incurred upon returning the grill as stated above within 10 days or per PCCBM agreement.
- Completeness of Contract:** This usage agreement is intended to be the complete and exclusive statement of the terms of the agreement between the Portage Curling Club and you. There are no sided agreements either verbal or written.
