- To attend all required coaching, safety and other clinics provided by Antioch Little League or District 4.
- To participate and organize participation by all of my team players, coaches, and families in all league activities, including, but not limited to; fundraising, work parties, field maintenance, etc.
- To refrain from and prohibit the use of alcoholic beverages, tobacco products and drugs at all Little League functions and events (I.E. games, practices, tryouts, etc)
- To read thoroughly, learn and abide by the **Little League Official Regulations and Playing Rules, Antioch Little League Operating Policy, Bylaws and Playing Rules, Antioch Little League Constitution.**
- My behavior and actions at all Little League activities will be non-confrontational and above reproach at all times.
- To treat my players, parents, fellow coaches, umpires, spectators and league officials with respect at all Little League activities.
- To refrain from abusive, vulgar, offensive, demeaning and/or inappropriate language at all Little League activities.
- To set an example of good sportsmanship and fair play for my players, coaches, parents and spectators.
- To continually improve my coaching knowledge and skills through ongoing study and education.
- To build confidence in my players by providing positive coaching reinforcement and stressing the importance of teamwork and good sportsmanship.
- To concentrate on teaching baseball or softball skills; that will be used by players throughout their playing careers, as a normal part of the game
- To focus on the continuing development of the players, helping them to learn to play better baseball or softball, and to emphasize the fun above winning or losing.
- To be a team player and act in the best interest of the league (I.E. resolve conflicts within the league leadership first without undermining the league or Board).
- To take care of all league provided property and equipment, including all playing and practice fields, equipment, and buildings.
- To return all equipment in my trust within two weeks of my final game.
