Assumption of Risk:

I, the undersigned parent of the Minor Participant and the Minor Participant, consent to my and/or Minor Participant's participation in the baseball/softball activities ("Activities") and acknowledge that Minor Participant and I fully understand participation in Activities may involve risk of serious injury or death, including losses which may result not only from my or Minor Participant's own actions, inactions or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, and/or the rules of play of this type of Activity.

COVID-19:

I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Center for Disease Control and Prevention ("CDC") guidelines ("COVID Guidelines") regarding COVID- 19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the COVID Guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent COVID Guideline updates. Notwithstanding the risks associated with COVID- 19, I hereby willingly choose to participate/attend in the Activities. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being in or about the location of Activity and participating/attending in the Activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on my behalf and any minor children for whom I have the capacity to contract) North Hills Athletic Association, 1000 Ross Park Mall Dr., Pittsburgh, PA 15237, its members of the board of directors, officers, agents, employees, coaches, volunteers, other participants, and assigns (collectively, the "Released Parties"), from any liability related to COVID-19 which might occur as a result of participation/attendance in Activities.

Release and Indemnification:

In consideration of allowing Minor Participant to participate in the Activities, I hereby release and hold harmless the Released Parties, of and from, and do discharge and waive, any and all claims, demands, losses, damages, and liabilities that I and/or Minor Participant may have or sustain with respect to any and all damage and/or injury, of any type, arising out of participation in the Activities.

The undersigned parent/guardian further agrees to indemnify, save and hold harmless the Released Parties from any and all claims, demands, losses, damages and liabilities for indemnities, contribution or otherwise with respect to any damage and/or injury, of any type, arising from participation in the Activities. The undersigned also agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by me or Minor Participant and is intended to be as broad and inclusive as is permitted by the laws of the Commonwealth/State in which the Activity is conducted.

I also agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
