



**WAIVER RELEASE FOR COMMUNICABLE DISEASES,
INCLUDING COVID-19**

ASSUMPTION OF RISK/WAIVER OF LIABILITY/INDEMNIFICATION AGREEMENT

In consideration of my participation and license to participate in the Minisink Valley Little League program, and related events and activities, and the participation of my minor child in said events and activities, the undersigned acknowledges and agrees as follows:

1. I admit and acknowledge that participation in activities and events with Minisink Valley Little League (MVLL) including any and all activities and events occurring at the VFW fields, Greenville Park fields, and any other locations used for league related activities, may possibly expose myself and my child to illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. I also admit and acknowledge that I may be exposed to said viruses and may be asymptomatic, but may be a carrier of said viruses with the possibility of making someone else ill with whom I have contact. While rules and regulations put in place by MVLL and my own personal discipline and my child's personal discipline may reduce this risk, I acknowledge that the risk of serious illness and death does exist, and may be more serious if either myself or my child had a pre-existing condition; and,

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, or others, and assume FULL RESPONSIBILITY FOR MY PARTICIPATION AND THE PARTICIPATION OF MY CHILD; and I willingly agree to comply and to encourage and require the compliance of my child with the stated and customary terms and conditions for participation in MVLL as regards protection against infectious diseases. I also willingly comply, and will enforce the compliance of my child with those rules and regulations put in place by MVLL to protect against the spread of infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, or the presence or participation of my child, I will remove myself or my child from participation and bring said hazard to the attention of the nearest MVLL official immediately; and I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, and on behalf of my minor child(ren), HEREBY RELEASE AND HOLD HARMLESS MINISINK VALLEY LITTLE LEAGUE, THEIR OFFICERS, THEIR OFFICIALS, AGENTS, AND/OR EMPLOYEES, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND IF APPLICABLE, OWNERS AND LESSORS OF THE PREMISES USED TO CONDUCT THE EVENT (OTHERWISE KNOWN AS "RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, BOTH FOR MYSELF AND MY CHILD.



3. PARENT'S/GUARDIAN'S SIGNATURE SHOULD BE USED FOR ANY MINORS. By signing this waiver, the parent or legal guardian agrees to the above statements. Parent or legal guardian must sign a new waiver for each individual player. Coaches must sign a waiver for their own participation.

FOR PARTICIPANTS OF MINORITY AGE (UNDER AGE 18 AT THE TIME OF REGISTRATION)

This certifies I, as parent/guardian, with legal responsibility for this participant in activities and events with Minisink Valley Little League, have read and explained the provisions in this waiver/release to my child/dependent, including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against communicable diseases. Furthermore, my child/dependent understands and accepts these risks and responsibilities. I, for myself, my spouse, and my child/dependent do consent and agree to his/her release, provided above, for all the Releasees and myself, my spouse, and my child/dependent do release and agree to indemnify and hold harmless the Releasees for any and all liabilities incident to my minor child/dependent presence or participation in these activities as provided above, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent provided by law.
