1) Elections:

- f. Concessions 2 year term: will remain an open position
- g. Registrar: Danica would like to remain in the position. Jen set forth a motion to nominate Danica for the position of Registrar. Hillary 2nd. Blind vote in favor, motion passes.

- h. Fundraising Chair: Jen Skinsacos is interested in the position. She has a background in fundraising and is on several different committees for this purpose. She feels she would be an asset to the program in bringing in fresh ideas for raising money as well as running programs we already have established. Danica set forth a motion to nominate Jen S. for the position of Fundraising Chair. Jen W. 2nd. Blind vote in favor, motion passes.
- 2) Brian Heal has issued in resignation from the position of Director of Marketing. He feels he cannot dedicate to the position like he needs to and has found a replacement for his position. Katy Rice would like to be considered for the Director of Marketing position. Marketing and Social Media are things that she works with in her job and feels she could help promote the program and work with the intern to help him complete his job as well. Jen W. set forth a motion to nominate Katy for the position of Director of Marketing. Danica 2nd. Blind vote in favor, motion passes.

3) Fundraising

- a. Crop-

4) <u>Treasurer</u>

a. QuickBooks is working well for Hillary to be able to keep our checking account squared away and up to date.

5) Concessions

- a. We need to have a better tracking system in place to be able to tell exactly how much we are selling and how much we a spending to restock.
- b. Concessions person needs to have a debit card and make purchases with that not cash. With receipts going to the Treasurer for accountability.

6) Miscellaneous items

- a. No more unapproved charges. At least the President needs to approve the small charges and big things need to be approved by the board.
- b. The fence around the field is not coming down.
 - 1) Banners are no longer allowed to hang on that fence as permanent fixture, will need to be removed after each game. Possibility of using S hooks to hang.
- c. Next Season- POD and bleachers will need to be in a different location. There also needs to be a box painted onto the field for the away team (coordinate with city for this)
- d. Fan apparel- Next year we should move to an online provider such as Atlantic. Parents can order direct through website, removing need for board to coordinate.
- e. Communication-Gmail- anyone who checks it, if you read it you're responsible to handle it. If you aren't going to respond and take care of the email then mark it unread. Please also be checking to ensure someone else hasn't already responded (people don't need to get more than 1 response).

7) Board of Directors
