**John Cimino**

- Survey for Parents to determine who would play late/alternate season?
  - What is your sentiment about playing baseball in 2020 - What do our families feel about re-opening?
    - June/July/August/Sept
    - This will include 50/70
    - USABL is looking to start as soon as they can in the summer
  - If we get a survey back that we should re-open, there are many guidelines we will need to follow and put thru – see Nebraska email.
    - NJ/Hamilton will have their own criteria
      - Will need to follow Twp & State guidelines
      - Will need to consider how to police the guidelines
        - Consider a committee who can oversee the guidelines and allow for inventory
        - Considering we will likely start later than other states, we will benefit from their guidelines and working out the kinks.
      - Change game times to allow for time between games so that we can follow guidelines.
      - May need to decrease the amount of games so we don't have all 3 fields being used at the same time.
  - All Stars – has not been ruled out on the local level leading up to Districts
    - World Series/Regionals canceled.

- Whether we continue to host the 9's tournament, will depend on what the other LL's are doing.
    - State of Emergency in NJ is on until June 6<sup>th</sup> as of right now.
    - Concession stand?
