# GRAND COUNTY SOCCER CLUB ANNUAL MEETING MINUTES

### I. Call to order

President: Call to order - 2019 Grand County Soccer Club, Annual meeting.

Tony DePlata called the meeting to order and explained that Brad McClain has stepped down from GCSC board as president and member.

### III. Approval of minutes from last meeting

### IV. Club Member open discussion.

# i) Rob Kauffman, Coach of the 2019 13U boys team stated concerns and comments.

- He believes coaches should be set earlier Tony responded the Club likes to have coaches lined up early, but it can be difficult due new team formation and lack of coaches coming forward.
- (2) He believes tryouts should be called evaluations and the date set and sent out to families earlier with multiple dates. He also mentioned he thought some people didn't get emails for tryout dates. Tony multiple dates are difficult due to the short window set by CSA to perform tryouts and register teams and other conflicts (Lacrosse, end of school activities). The Club will look into the possibility of mid-week tryouts with multiple dates.
- (3) He recommended getting evaluations from Rec coaches. The Club will look into possibilities of this. The Club would need to be involved in the evaluation process.

He would like to see better communications between Club/coaches/parents. He recommended the club pay for app for team communications The club will look into options available through our website. Christine would like to look into costs for Teamsnap, The Club is willing to look into paying for team communications

- (4) He would like have refs set up earlier Tony agreed explained issues with ref shortages and difficulty getting people to ref. Club will look into recruiting referees earlier and the possible getting interested coaches certified. The Club's goal is to have refs certified well before the season starts.
- (5) He would like to have earlier play dates. -Tony explained the Club sends a field play time request to CSA, but ultimately CSA sets the play locations and dates. The Club is looking at options to limit the field availability so games will get scheduled earlier in the season.
- (6) He would like to ensure uniforms are to the players before first game. -Tony agreed, explained the uniform order is currently placed all at once and the difficulty in getting all sizes for players, holding up the entire order. The Club is looking into parents ordering direct from supplier to eliminate club or coaches needing to collect. Loran discussed the possibility of recycle uniforms. The club would support this. Jackie agreed and mentioned this could also include cleats.
- (7) He would like to see dome times set earlier Granby rec will set up a dome schedule meeting in early December to set winter and spring dome times. This will allow for dome scheduling at the beginning of the 2020 fall season.
- (8) He would like to set up spring tourneys Tony explained this has been typically left up to coaches that are interested in getting a team together, Club will support what they would like to do.
- (9) Dino coaches shouldn't get charged for their player, Loran would like to see more support for rec coaches Jackie is interested in holding a coaches 101 class and options to keep kids on the ball over the winter.
- (10) Tony DePlata discussed the possibility of holding a mandatory parent/coaches meeting before next season to discuss many of these issues, so there is a general understanding of Club expectations. The general consensus of those at the meeting was this is a good Idea

### ii) Elliot Lauber with Granby Rec

(1) Granby Rec will be hiring an individual to run the athletic programs. With this addition Granby Rec proposed they would like to completely take over the rec soccer program. Including registration. Club would not be involved at all. – The Club would discuss this issue in future meetings.

## iii) Dino Kaplanis – Coach of the 2019 14u Girls

- b) He discussed wanting to keep his team together for next season. The Tony and Christine explained the Club likes to try, to the best extent possible, to keep teams together as they are moving up in age divisions if possible.
- c) He discussed the possibility of children of coaches playing for free. The Club will look into the possibility of this
