ASSUMPTION OF RISK, WAIVER AND INDEMNITY AGREEMENT

(PLEASE READ CAREFULLY)

Warning: By signing this Agreement, you are giving-up the right to sue for any injury, illnesses, or damages howsoever caused.

1. I, _____, certify and volunteer the following on behalf of myself and my child, _____ ("child"), and I hereby request that Evansville Youth Soccer League, Inc., Indiana Soccer Association, Inc., and the City of Evansville, and each of its insurers, sanctioning bodies, managers, representatives, officers, directors, commissioners, employees, members, coaches, designates, agents, subsidiaries, parents and affiliates (collectively "Host"), permit myself and my child, to participate in the sport of soccer, tournaments, practices and other related activities (collectively "Sports").
2. By signing this Agreement, I acknowledge that I have the capacity to enter into this document on behalf of myself and my child, that I and my child are healthy and fit to play Sports and that it is my obligation to inform the Host in writing of any limitation that causes myself or my child to be unable to safely participate in Sports. I understand Sports is a physical activity which involves serious inherent risks which may result in injury, illness, or even death. Such risks include, but are not limited to, accidental or negligent contact with other persons or property, motor vehicle travel, changing weather, variations in terrain, both manmade and natural, or accidents, or illness including but not limited to any and all viral or bacterial illnesses spread through close contact, cross-contamination or otherwise, including but not limited to COVID-19, all in potentially remote locations without immediate evacuation or medical facilities (collectively, the "Risks").
3. I give my approval for myself and my child's participation in Sports, and transportation to and from the same, and am **assuming all risks and hazards incidental thereto.**
4. IN CONSIDERATION FOR THE PRIVILEGE OF PARTICIPATION IN SPORTS AND OTHER VALUABLE CONSIDERATION, I, ON BEHALF OF MYSELF AND MY CHILD, HEREBY FULLY RELEASE, WAIVE, INDEMNIFY, HOLD HARMLESS AND DISCHARGE TO THE FULLEST EXTENT PERMITTED BY LAW, THE HOST FROM AND AGAINST ANY CLAIMS, ACTIONS, DEMANDS, ATTORNEY AND EXPERT FEES, DAMAGES, LOSSES, COSTS, EXPENSES AND/OR LIABILITIES, WHETHER SUCH ARISES BASED ON NEGLIGENCE OR BY ANY STATUTORY OR COMMON LAW THEORIES, (INCLUDING WITHOUT LIMITATION ALL INJURIES, ILLNESS, DISABILITY, OR DEATH, ARISING OUT OF OR IN CONNECTION WITH SPORTS AND RISKS, THE GRANT OF RIGHTS HEREUNDER OR BREACH OF THESE REPRESENTATIONS AND WARRANTIES AND EVEN THOUGH THAT LIABILITY MAY ARISE OUT OF THE CONTRIBUTORY NEGLIGENCE OR CARELESSNESS ON THE PART OF THE HOST, EXCLUDING WHERE THE COMPLEX IS SOLELY NEGLIGENT (COLLECTIVELY, "CLAIMS"). I HEREBY AGREE THAT THE HOST SHALL NOT BE LIABLE FOR ANY INJURY OR LOSS WHICH MYSELF OR MY CHILD MAY SUSTAIN WHILE PARTICIPATING IN SPORTS OF ANY KIND WHETHER SPONSORED BY OR UNDER THE SUPERVISION OF THE HOST AND WE AGREE TO INDEMNIFY AND TO HOLD HARMLESS THE HOST, FROM ANY CLAIM(S) WHATSOEVER INCLUDING BUT NOT LIMITED TO REASONABLE ATTORNEY'S AND EXPERT FEES.
5. I grant the Host the right to use photographs, film records or likenesses of my child and me/us for future promotional purposes. This right also shall be granted for use by third parties that may enter into any joint promotional effort with the Host.
6. I appreciate that this Agreement applies whether the Host is at fault or not, and it exonerates and limits the liability of the Host's managers, representatives, officers, directors, employees, members, coaches, designates, agents, subsidiaries, parents and affiliates to the same extent as it limits the liability of the Host, even though said persons or entities may not be construed as formal parties to this Agreement. I understand that the Host, in securing execution of this Agreement by myself, is acting as agent or trustee on behalf of, or for the benefit of, managers, representatives, officers, directors, employees, members, coaches, designates, agents, subsidiaries, parents and affiliates, who shall to this extent be, or be deemed, to be parties to this Agreement. This Agreement shall be binding on all respective heirs, devisees, personal representatives, guardians, offspring, children, successors and assigns of all parties to this Agreement. This Agreement shall be construed under, and governed by, the laws of the State of Indiana, and all parties hereto consent and agree to the exercise of jurisdiction over any matter arising in connection with this Agreement shall be in the Superior Court of Vanderburgh County, State of Indiana. This Agreement reflects the complete understanding between the parties with respect to its subject matter, and cannot be modified except in a writing signed by both the Host and the undersigned.

I have read and understand this Agreement. I understand that this document contains a promise not to sue the Host and a release and indemnity for all Claims. I also represent that I am a parent/guardian of the minor child named above under 18 years of age (if applicable) and I agree that the above binds myself and said child to all terms herein.
