



Fall COVID Waiver

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 *

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Metro Area High Performance aka Metro Hockey Club ("MetroHC") has put in place preventative measures to reduce the spread of COVID-19; however, METRO HC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending METRO HC programs could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this agreement, I ACKNOWLEDGE the contagious nature of COVID-19 and VOLUNTARILY ASSUME THE RISK that my child(ren) and I may be exposed to or infected by COVID-19 by participating in or attending METRO HC programed events and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself, my spouse, guests, child(ren), unborn child, or relatives. I understand that the risk of becoming exposed to or infected by COVID-19 while participating in a METRO HC program may result from the actions, omissions, or negligence of myself and others, including, but not limited to, METRO HC employees, volunteers, and program participants and their families.

I AGREE AND UNDERSTAND AND VOLUNTARILY ACCEPT AND AGREE TO ASSUME ALL of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s participation at a METRO HC program. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless METRO HC, its employees, agents, and representatives, of and from any METRO HC program, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. Further, I UNDERSTAND AND AGREE that this release includes any Claims based on the actions, omissions, or negligence of METRO HC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any METRO HC program or related event.
