

Guidelines for the J&C Financial Assistance Program

The J&C Financial Assistance Program shall be administered by the J&C Financial Assistance Committee. The Financial Assistance Committee shall: 1) be responsible for reviewing applications, 2) granting scholarships, and 3) presenting a written report of granted scholarships to the Board. The Financial Assistance Committee shall consist of three (3) members of the Board. All information and discussion by this Committee shall be held in the strictest of confidence. Disclosure of a family's financial information by any member of the committee will result in that member being removed from the Committee and their child(ren) may be removed from the Club.

Awards will be credited to the applicants' Club account to **assist** with club dues. Parents and/or guardians are responsible for paying the club registration fee, purchasing the team uniform, and **All** associated team fees. The amount of the assistance per player will be determined by the committee each soccer season.

Applications must be submitted each season regardless if a family received prior assistance.

- The Financial Assistance Program will be based strictly on a financial need basis as determined by a parent or guardian's most recent tax return and other pertinent information as provided by the applicant.
- The program is available to both boys and girls of all ages.
- There is no limit to the number of children in a particular family that may receive financial assistance.
- Recipients must remain in good standing with J&C, inclusive of responsibilities associated with the J&C Code of Conduct, Team Fees, and prompt regular attendance to training and games.
- **Recipients will be required to volunteer their time helping out during Club sponsored Tournaments and/or Fundraisers. The Financial Assistance Committee will evaluate each recipients' level of participation each season to determine if they fulfilled their obligation.**
