January

Date	League - District	Task
1 st	League	2020 Charter Packages have been sent out to Leagues
15 th	District	Submit District 2019 financial statement to Regional Office

February

Deadline	League - District	Task
1 st	League	All residency eligibility documents for players who have not previously completed an approved player verification Form must be either dated or in force between February 1, 2019 and February 1, 2020

April

Deadline	League - District	Task
15 th	League	<ul style="list-style-type: none"> Submit Charter application to Regional Office. Include proof of insurance, boundary map, and current bylaws / constitution. Complete applications for Combined Teams and/or Interleague Play on the Data Center and notify you District Administrator for approval prior to commencement of regular season play.

May

Deadline	League - District	Task
30 th	District	Martha Dubroy District Volunteer of The Year Award nominees due date

June

Deadline	League - District	Task
1 st	League & District	Any waiver request pertaining to the eligibility of a player, team, manager, or coach must be submitted in writing, by the President of the local Little League®, through the District Administrator, to the Regional Office. Requests received after this date will not be considered.
1 st	League & District	<ul style="list-style-type: none"> Charter fees must be paid. Final day to request team adjustments. After this date Leagues will not be refunded. All outstanding Charter fees must be paid prior to registering Tournament Teams. If your league has an outstanding balance of \$300 or more, the league will be put on "financial hold" and may not be eligible for Tournament Play until the account is cleared.
1 st	League & District	<ul style="list-style-type: none"> Canadian tournament information packages will be sent to all leagues Applications for Combined Teams for Tournament Play will not be accepted after this date.
1 st	League & District	Recognition Awards nominees must be submitted to Regional Office by June 1 st)
15 th	League & District	Roster Due Date , Submitted through Data Center
15 th	League & District	Submit completed Confirmation of Regulation Compliance and Tournament Enrolment Application to Regional Office.
15 th	District	DA elections concluded and submitted
30 th	League & District	Ensure your DA has submitted your Tournament Team Eligibility Affidavits and the \$400 per team Tournament Entry Fee to the Regional Office prior to teams participating in International Tournament Play.

July

Deadline	League - District	Task
1 st	League	Submit Tournament Team Eligibility Affidavits and \$400 per team Tournament Entry Fee to your District Administrator, prior to participating in International Tournament Play.
1 st	District	Submit final District and Divisional Tournament schedules to Regional Office for approval.

NOTE: Canadian Tournament Hosting Fee **MUST BE PAID** in full prior to commencement of the Canadian Regional Tournament: \$18,750 for Little League® Baseball and \$6,250 for Intermediate (50/70), Junior, and Senior Baseball and \$2,000 for all softball levels.

August

Deadline	League - District	Task
15 th	League	Submit Tournament Advancing Fees to Regional Office: Divisional participants \$535 per team for each level and Regional participant's \$1,665 per team for each level.
15 th	League	Submit to your DA the District and Divisional \$55 per game assessment fee for all levels of baseball and softball.

September

Deadline	League - District	Task
1 st	District	Submit to Regional Office the District and Divisional \$55 per game assessment fee for all levels of baseball and softball.
15 th	District	DA elections criteria must be met for election to be valid
30 th	League & District	FISCAL YEAR END: Ensure that all League and District accounts are paid in full including any outstanding monies owing for supplies, fees, and/or assessments. All outstanding accounts are subject to review and penalty after September 30, 2020.
