**F. *Training Dates*** – Will continue through Spring to use current scheduling system. - Murfreesboro is hosting Region III Finals this summer and a request for field sponsorship was made. There will be a discount on sponsorship fee if secured by 3/1. Volunteers are needed as well. Sign-up is done on Murfreesboro's web-site. This will be taken under consideration for NRS/SRFC. Tournament dates are 6/16-19.

**C. Rain Insurance** – If a rain-out occurs for the SRFC tournament, SRFC will not be required to pay for field usage.

**D. Parent Request for Child to Play down** – Beth Bugg has requested that her 7 year old be allowed to play U5-6 due to developmental delays. If allowed, there would be insurance considerations. Will evaluate more in-depth including an evaluation of the child's ability.

**E. DNJ Advertisement** – Discussed if an ad should be placed in the DNJ. Given the timeframe for publishing and registration close dates, an ad will not be placed for spring.

**F. Facebook Advertisement** – Discussed if an ad should be placed in Facebook. It was decided not to pursue at this time.

**G. Uniforms Director Resigned** – Due to personal time commitments, Tina Adam has resigned as Director of Uniforms.
