

**COVID-19 Liability Release**

**Indemnity Agreement Regarding Coronavirus Disease (COVID-19)**

I have read and understand the State of Michigan’s Return to Play Plan in its’ entirety and have determined the plan to be reasonable in the precautions taken to prevent the spread of Coronavirus Disease (COVID-19). I understand that playing and preparing to play sports poses certain inherent risks, including, but not limited to: infectious disease exposure, including Coronavirus disease (COVID-19); serious injury, including permanent disability; and death. I further understand that I, and/or on my child’s behalf, have a responsibility to stay home when experiencing symptoms of illness, including, but not limited to the symptoms of Coronavirus Disease (COVID-19), and to report to Plymouth Canton Steelers Junior Football any positive results for Coronavirus Disease (COVID-19) for anyone in my household.

In consideration of my use, or my child’s use, of the equipment, facilities, and instruction provided by Plymouth Canton Steelers Junior Football and participation in games for the local league and/or in tournaments, I expressly agree and contract, on behalf of myself, my heirs, executors, administrators, successors and assigns, that Plymouth Canton Steelers Junior Football including but not limited to: their insurers, employees, members, officers, directors, and associates, successors, assigns, partners, subsidiaries, and heirs, shall not be liable for any damages arising from personal injuries (including death), in relation to Coronavirus Disease, also known as COVID-19, or in the case of a minor, my child, in, on, or about the premises, or as a result of the use of the equipment or facilities, regardless of whether such exposure to Coronavirus disease (COVID-19) result, in whole or in part, from the negligence and/or willful disregard of Plymouth Canton Steelers Junior Football.

By the execution of this agreement, I accept and assume full responsibility for any and all injuries, damages (both economic and non-economic), and losses of any type due specifically to Coronavirus disease (COVID-19), which may occur to me or my child, and I hereby fully and forever release and discharge Plymouth Canton Steelers Junior Football including but not limited to: their insurers, employees, members, officers, directors, associates, successors, assigns, partners, subsidiaries, and heirs, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated, or unanticipated, resulting from or arising out the use and participation of said instruction, equipment, and facilities.

I expressly agree to indemnify and hold Plymouth Canton Steelers Junior Football including but not limited to: their insurers, employees, members, officers, directors, associates, successors, assigns, partners, subsidiaries, and heirs harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages due to Coronavirus disease (COVID-19) sustained by me or my child, including the costs of legal defense.

I agree to comply with all rules imposed by Plymouth Canton Steelers Junior Football regarding the use of the facilities and equipment. I agree to conduct myself in a controlled and reasonable manner at all times, and to refrain from using any equipment in a manner inconsistent with its intended design and purpose. I understand and acknowledge that participation in athletics, particularly football and its’ preparation, involves risk, including but not limited to: infectious disease exposure, including Coronavirus disease (COVID-19); serious injury, including permanent disability; and death.
