Making a Payment There are two ways to make payments.

**Credit Card**—Log into your SportsConnect account and pay online. Credit Cards payments will be processed automatically on the due dates noted above for payment plans.

**Check/Cash**— Checks can be mailed or dropped off at our office. Cash must be turned in to our office in person.

**Failure to make sufficient payments on required player dues, will result in players being unable to attend practices and games. Total due March 5th 2021**

### **U15-U19 PLAYER DUES— Paid Via SportsConnect Account**

#### **Cost Includes:**

- Player training fees May 2020 to May 2021
- Player, coach and team registration with governing association
- All League entry fees
- State Cup/Presidents Cup/Founders Cup entry fee
- Use of fields & equipment
- College Fit-Finder Account
- Coaches compensation throughout the season
- Administrative services from a professional staff

#### **Cost Does NOT Include:**

- Required uniforms and training gear

#### **TEAM ACCOUNTS: Paid via Team Treasurer**

Each team will have a team account that players will need to deposit money into. These accounts will help each team cover the following cost;

- Showcase Entry Fees
- Travel (flights/gas, food, hotel, rental cars, coach and manager cost, etc.)
- And other misc team cost

**All information listed below must be agreed to within players SportsConnect acceptance. Failure to do so may result in player offer being withdrawn and players being ineligible to attend any further practices or events.**

**Release of Liability:** I, the parent/guardian of the registrant, a minor, agree that the registrant and I will abide by the rules of FC Portland Academy (hereafter referred to as FCPA), it's affiliated organizations and sponsors. Recognizing the possibility of injury associated with soccer and in consideration for FCPA accepting the registrant for its soccer programs and activities, I hereby release, discharge and/or otherwise indemnify FCPA, its affiliated organizations and sponsors, their Board of Directors, their employees and associated personnel, including the owners of fields and facilities utilized for the programs, against any claim by or on behalf of the registrant as result of the registrant's participation in the programs and/or being transported to or from the same, which transportation I hereby authorize. I give my permission for all medical care deemed necessary by a fully licensed doctor of medicine in my absence, for my dependent.

**Payment of Fees & Other Costs:** I, the parent/guardian of the registrant, agree to pay FC Portland Academy the full \$1220 (\$1284 for payment plan) for U15-U18/19 Player dues; failure to pay account on due date will result in a \$10 surcharge. I understand that payments are nonrefundable, and I will be responsible for paying any unpaid fee balance *at the time of withdrawal* should he/she withdraw from the program at any time for any reason other than serious injury. Furthermore, I understand that U15 - U19 fees will cover the following: training fees from July 2020 to May 2021, OYSA competitive league fees; OYSA competitive tournament fees, OYSA player registration fees; coaches' compensation; and use of field equipment and playing fields at Liberty HS. I understand that U15 - U19 Fees do not cover any additional expenses, including (**but not limited to**): Out of state events; player tournament travel and participation fees; gym fees; or required uniform or training gear.
