

Assumption of the Risk, Waiver and Release of Liability Relating to COVID-19

Tabernacle Presbyterian Church and Tab Recreation (“Tab”) has put in place preventative measures to reduce the spread of COVID-19 (the **“Return to Play Protocols”**); however, Tab cannot guarantee that you, your spouse, or your child(ren) (the **“Participant(s)”**) will avoid infection. Further, attending or participating in practices, training, scrimmages, games, and tournaments (collectively **“Tab Activities”**) may increase your risk, your spouse’s risk, and the Participant(s)’s risk of contracting COVID-19.

In consideration of the Participant(s) named below being allowed to attend and participate in Tab Activities, I, for myself, my spouse, and the Participant(s), sign this Assumption of the Risk, Waiver and Release of Liability Relating to COVID-19 (the **“Agreement”**). By signing this Agreement, I, for myself, my spouse, and the Participant(s):

1. Acknowledge the contagious nature of COVID-19 and understand that the risk of becoming exposed to or infected by COVID-19 while attending or participating in Tab Activities may result from the actions, omissions, or negligence of the Participant(s), my spouse, myself, and others, including, but not limited to, Tab, its directors, contractors, employees, and volunteers, other Tab participants and their families, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used to prepare for conditioning, football, and Tab activities at Tabernacle Presbyterian Church (collectively the **“Releasees”**).
2. Freely and voluntarily assume the risk that the Participant(s), my spouse, and I may be exposed to or infected by COVID-19 by attending or participating in Tab Activities and that such exposure or infection may result in injury to the Participant(s), my spouse or myself including, but not limited to, personal injury, illness, permanent disability, and death (collectively the **“Risks”**), and assume full responsibility for the Participant(s)’s, my spouse’s and my attendance and participation in Tab Activities.
3. Hereby waive, release, discharge and hold harmless Tab and all Releasees of and from the Risks, including all liabilities, claims, actions, damages, costs or expenses of any kind (collectively the **“Claims”**), arising out of or relating thereto. I understand and agree that this release includes any Claims based on the action, omissions, or negligence of Tab and the Releasees, whether a COVID-19 infection occurs before, during, or after attendance or participation in Tab Activities.
4. Agree to comply with the Return to Play Protocols implemented by Tab and other preventative measures recommended by federal, state, and local governments and federal and state health agencies to reduce the spread of COVID-19 or, at the Tab’s sole discretion, forfeit the opportunity to attend or participate in Tab Activities.
5. Agree that if the Participant(s), my spouse, or myself have:
 - A temperature of 100.4 F or above,
 - Any COVID related symptoms (cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell, all of which have been identified by the CDC as possible symptoms of COVID-19),
 - Had a positive COVID-19 test in the past fourteen (14) days, or
 - Had close contact (i.e., in my household or within 6 feet) in the last fourteen days with an individual who has tested positive for COVID-19 or who showed symptoms of COVID-19, the Participant(s), my spouse, and myself will not attend or participate in Tab Activities and will immediately contact the Director of the Tab, Ben Hughes, at ben.hughes@tabpres.org.

I, as the parent/guardian of the Participant(s), certify that I have read and explained the Return to Play Protocols with the Participant(s) and his/her personal responsibilities for adhering to the rules and regulations for protection against COVID-19.

TABERNACLE PRESBYTERIAN CHURCH: PARENT/GUARDIAN CONSENT AND RELEASE FORM

Any equipment that is furnished to or used by the participant is made available merely for our benefit and the benefit of the participant. I/We understand that TAB makes no representation as to such equipment's quality or fitness for use or as to the selection of such equipment. Participant assumes all risk of injury to person or property arising out of the use of such equipment supplies by TAB whether the equipment be rented, owned or otherwise, for the use of the participant named above, including any claim or causes of action for an alleged defect in any and all equipment supplied by TAB. . If we are not personally present at the activities in which the participant is to participate so as to be consulted in the event of necessity or emergency, you are hereby authorized on my/our behalf to arrange for such medical, dental, hospital, or health care treatment as you may deem advisable for the health and well-being of the participant. I/We assume all financial obligation for all medical, dental, hospital, or health care services given to my/our child/ward.

I/We give my permission to use my child's name, likeness, image, voice, and/or appearance as such may be embodied in any pictures, photos, video recordings, audiotapes, digital images, and the like, taken or made on behalf of Tab Recreation and Tabernacle Presbyterian Church Program activities. I agree that Tab Recreation and Tabernacle Presbyterian Church Program has complete ownership of such pictures, etc., including the entire copyright, and may use them for any purpose consistent with the Tab Recreation and Tabernacle Presbyterian Church Program mission. These uses include, but are not limited to illustrations, bulletins, exhibitions, videotapes, reprints, reproductions, publications, advertisements, and any promotional or educational materials in any medium now known or later developed, including the Internet. I acknowledge that I will not receive any compensation, etc for the use of such pictures, etc., and hereby release Tab Recreation and Tabernacle Presbyterian Church and its agents and assigns from any and all claims which arise out of or are in any way connected with such use.
