COMMUNICABLE DISEASE RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

In consideration of being allowed to participate at any level or capacity in any program, sport, activity, or event associated with NLYAA, I, the undersigned acknowledge and agree that:

- 1) As a parent and/or legal guardian, I am aware that there are risks to my child, myself, and my family of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to the Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2) which is responsible for Coronavirus Disease (COVID – 19) and/or any mutation or variation thereof.
- 2) As a parent and/or legal guardian, I am aware that the NLYAA is not responsible to provide a full refund in the event of a sport stoppage. In addition, I do not hold the NLYAA financially accountable for any monetary reimbursement in the event that the sport season is not fully completed.
- 3) As a parent and/or legal guardian, I am aware that the NLYAA will provide guidelines for sports with the intent to mitigate the spread of any and all communicable diseases, including but not limited to SARS – CoV-2 / COVID – 19. I agree to follow the guidelines as issued by NLYAA.
- 4) I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin hereby release, indemnify, and hold harmless the Northern Lehigh Youth Association (NLYAA), its officers, coaches, and agents from any and all claims, demands, losses, and liability arising out of COVID-19 or related to any illness, injury, disability or death that I, my child, and/or my family may suffer, whether arising from the negligence or otherwise of any coach, officer, and or agent associated with the NLYAA to the fullest extent permitted by law.
- 5) I understand that if I traveled to any state within the United States of America identified by the Pennsylvania Department of Health as an area with high amount of COVID-19 cases, I will not be allowed to participate in any NLYAA activities for 14 days as of the date of my return.
