- Lining the fields for fall soccer—who will do this?—Tim & Jennifer Bink have volunteered to line the fields; Jennifer will talk with John Wolfenburg about getting a deal on the paint; Kiel Recreation Department supplies one pallet of paint.
- Grants—do we have any grants awaiting approval?—Jennifer B. has sent some out and is working on them
- Field 2 goal damaged—Bob R. talked with Eric M. about fixing it; Eric M. will look into the state law about goals needing to be staked down; \$500.00 fine
- A request from several coaches to leave the fields as you find them.
- New board members meet with Bob R. And Joe B. to discuss soccer complex items(outstanding loan & tax items)—This will take place.
- New nominations for open positions—How will this be handled?—The board will look into elections/nomination process
- Rodnie P. would like to archive minutes.
- Ben Summers proposed having a tournament in Kiel. He will have more information at the September meeting. He would like to form a committee between now and January.
