Mandatory Parent's Meeting (6:00 pm)

Joe Molitor conducted the mandatory parent's meeting with a slide presentation. Monthly March Meeting

President's Report:

Rodnie attended the AGM meeting in Green Bay. WYSA has streamlined the player pass processing to allow it to be handled by the clubs. WYSA is now incorporated. The 501©3 status has been applied for and is moving through the process. WYSA has been recognized as the state youth association in Wisconsin. The State Registrar position has been eliminated. There is a proposed WYSA membership fee rebate if there is an overall increase in 2010-11 membership over 2009-10 membership.

Vice President:

The Mr. Zs pizza fundraiser started today. Order forms need to be returned to Jennifer by April 18. Delivery date is May 21 from 9 am to 12 noon at the Kiel soccer complex. New this year is the opt-out cash option. The club needs to net approximately \$7,000 from this fundraiser to meet its expenses.

Picture Day will be April 29 and 30, and the company taking the pictures is Picture America. Committee members are Stacy Roehrig, Karin Wille, Michelle Loose, Tanya Schneider, Jina Bushke, Carolyn Christel, and Amy Pitzen.

Equipment day has not been set because of the weather (tentatively April 2). Traveling teams will receive 2 game balls and 3 practice balls. All players will be asked to bring their own soccer ball to practice.

The fields are still wet, so Mary-Beth will e-mail the coaches to practice at Zielanis until the fields have dried off.

Secretary's Report:

The club is looking at a new soccer sock (all purple). It is the same sock that the high school players wear. The cost would be \$8 per pair from Not Just Soccer in Sheboygan (with our club discount and tax-exempt status). The sizes are: mens 10-13; mens 5-9.5/womens 7-11; and womens small. Dawn Muehlbauer will take over ordering the soccer clothing starting the beginning of April.

The next tournament committee meeting will be at 5:30 pm on April 15 at the Kiel soccer complex.

New Business:

John Adema mentioned that he checked on the soccer complex and the donor board signage blew off. Jennifer will get bids to have this repaired.

All goals must be secured or the club is subject to a \$500 fine. Eric Muehlbauer and Chris Freund will work on getting some sort of staking devices made and installed.

Mary-Beth stated that Bob Radder received a request from the Kiel HS Booster Club for advertising in their spring girl's tournament brochure. Motion made by Mary-Beth Molitor to place a small ad in their brochure at a cost of \$20; seconded by Matt Steffen.

Items to be tabled for a later date: adult league soccer/usage of the soccer fields, and the alumni game in August.

Motion made by Joe Molitor to adjourn the meeting; seconded by Jennifer Bink. The meeting adjourned at 8:00 pm. The April meeting will be held at 6:30 pm on Monday, April 18.
