REGISTRATION MEMBERSHIP AGREEMENT

In order to ensure a meaningful and rewarding soccer experience for each player in the Rio Rapids Durango Soccer Club program, the club requires all players and their parents to adhere to basic rules, policies and guiding principles of the club. Although this agreement does not cover all of the policies of the club, nor does it address all potential issues, it does address many of the core concerns and issues that arise in the club each year.

PLAYER AND PARENT AGREEMENT

Rio Rapids Durango Soccer Club requires that all players and parents read and sign this agreement per the online registration or manually, as a condition of membership in the club. If you have any questions or concerns regarding this agreement, you should discuss them with your coach, or any board member, before signing.

Rules of Conduct

1. Parents have a financial responsibility and obligation to pay club fees on time according to the schedule established by the club.
2. Parents shall not:
 - Instruct or coach players at games or practices.
 - Make negative comments or criticisms to players, referees, or coaches at games or at practices.
 - Discuss issues of playing time or other coaching issues with the coach while at the game field or at the practice field. Such conversations must take place outside the presence of other players and parents, and not at the field.
 - Use alcohol, vape, cigarettes, or illegal drugs at practices, games or any team event.
3. Players:
 - Players must arrive on time for all practices and games, and should let the coach know of any absences from practices or games in advance.
 - Players shall not use or possess illegal drugs, alcohol, vape or cigarettes.
 - Players should be respectful and supportive of teammates and should not criticize referees or opposing teams and players.

Authority to Suspend or Remove Players

The coach and RRDSC board of directors have authority to suspend or remove players from the club for violation of these rules by the player or the parent. The authority to suspend or remove players is not limited to violations of the rules stated in this agreement, as it is understood there

may be instances of misconduct not listed here but which may nonetheless form the basis for suspension or removal.

Forfeiture of Fees

If a player is suspended or removed from the club or if a player voluntarily leaves the club for any reason, there shall be no refund of any monies paid to the team or club, and the player will remain obligated to pay remaining fees owed to the club.

Refund Policy

Rio Rapids Durango Soccer Club has adopted a no refund policy. After registrations fees are collected, refunds will not be given to players who do not play for the Club. In the event of extreme circumstances and/or hardship, the Board of Directors reserves the right to determine if a refund is warranted. Examples of reasons why the Club might not issue a refund include, but are not limited to, the following:

- The player or parent has a conflict with the coach or a player(s).
- The player is suspended or expelled as a result of a disciplinary action.
- The player becomes injured on or off of the field.
- The coach leaves the team, but Rio places another coach in his or her place.
- The player relocates out of town.
- The player has overcommitted to other sports, activities etc., and decides to not play soccer.
- The player cannot make the practice nights or field locations.

Transfers

Player's club and team fees must be paid in full before transfers are granted.

Scholarships

If you are awarded a scholarship, you are committed to the club for the entire season. Should you choose to leave the club, you will be responsible for paying your scholarship award back to the club as well as any other fees you owe to the club or your team. A release/transfer will not be approved until all balances are paid.

Photo Release

U13 and under Photo Policy: As the parent/guardian, I give permission to Rio Rapids Durango Soccer Club to publish photos of my son/daughter on the web site, and/or on social media platforms controlled by Rio Rapids Durango Soccer Club or as part of a related team web site. This permission does not extend to any personal information, and only includes the publication of photos. The location of the photos will be in a publicly accessible area on the internet that is not password protected. U14 and older Photo Policy: As the parent/guardian, I give permission to Rio Rapids Durango Soccer Club to publish photos of my son/daughter on the web site, and/or on social media platforms controlled by RRDSC as part of a related team web site. This permission does not extend to any personal contact information beyond parent/guardian email

address. The location of the names, biographical information and photos will be in a publicly accessible area on the Internet (not password protected).

Waiver of Liability

I hereby request that Durango Youth Soccer Association d/b/a Rio Rapids Durango Soccer Club allow my child to participate in the Rio Rapids Durango Soccer Club at locations to be determined. I understand that programming may include, but is not limited to Leagues, Camps, Clinics, Academy, Events, Alliance Events, and Competitive Teams. The language of this waiver is also intended to cover all tryouts, open-play sessions, travel, and trainings related to the Rio Rapids Durango Soccer Club.

In considerations in allowing my child to participate in the Rio Rapids Durango Soccer Club programming, I agree not to sue and forever release, waive and discharge Durango Youth Soccer Association d/b/a Rio Rapids Durango Soccer Club and its respective employees, governors, affiliates, agents, partners, owners, members, parents, subsidiaries, representatives, officers, attorneys, and players (hereinafter referred to collectively as "Releases") from any and all liability to me, my child and his or her personal representatives, assigns, heirs, children, dependents, spouse and relatives from any and all claims, causes of action, losses, judgments, liens, costs, demands or damages that are caused by or arise from any injury (including death) to his/her person or property regardless of the cause(s) of such injury. I assume all risks associated with my child's participation in and observation of the Durango Youth Soccer Association d/b/a Rio Rapids Durango Soccer Club.

I certify that my child is in good mental and physical condition. My child and I understand the inherent risks associated with participation in the club, and we also understand the inherent risks of participating in the sport of soccer at this level on a grass, astro-turf, blacktop, court, or other surface. I recognize the possibility of physical injury associated with soccer, and in consideration of above organizations discharge and otherwise indemnify the organizations, the affiliates and sponsors, their employees and associated personnel (whether paid or volunteer) as well as the owners of the fields and facilities utilized for the programs, against any claim by or on behalf of the registrant as a result of the registrant's participation in the programs.

I, the parent/legal guardian of the registrant, authorize the Durango Youth Soccer Association d/b/a Rio Rapids Durango Soccer Club staff to seek medical treatment for the Participant as they deem necessary at local medical facilities. I understand that this authorization is given in advance of any specific diagnosis, treatment or hospital care, and that it is given to provide the Rio Rapids Durango Soccer Club staff authority to seek medical treatment as he/she judges necessary to the above-named Participant. I accept responsibility for payment of all services rendered; I authorize any medical facility that renders services to release medical information necessary for the processing of insurance claims; and I authorize the payment of insurance claims directly to the medical facility. I understand that whenever possible, the Rio Rapids Durango Soccer Club will make a good faith effort to contact me or the above named person(s) before seeking treatment. If this is not possible, I understand that the Rio Rapids Durango Soccer Club staff will notify me, or my designee, as soon as possible of any and all diagnoses and treatments. I also hereby give consent for emergency medical care prescribed by a duly

licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life, limb, or well-being of my dependent.

I hereby acknowledge that I have carefully read this Liability Waiver and Release of Liability, that I fully understand its content, that I am over the age of 18, I am the legal guardian of the minor listed and that I am agreeing to this Liability Waiver and Release voluntarily and intend for its use to be legally binding.

*** READ BEFORE AGREEING ***

By accepting this agreement, you are promising that you will abide by the rules set forth herein, and you are also acknowledging and agreeing that if the coach or board determine that the parent or the player has violated these rules of conduct, or has engaged in other misconduct, the player can be suspended or expelled from the club with a forfeiture of all club fees.
