This Sign Sponsorship Agreement (“Agreement”) between the Linwood Baseball Association (hereinafter, “LBA”) and _____ (hereinafter, “Sponsor”) is made on _____, 20__.

Sponsorship of a sign in the LBA (“Sponsorship”) must be, for the Sponsor, out of a sense of duty to help the community. While Sponsorship does afford some benefits (detailed below), the higher purpose is to help the LBA impart the values of teamwork, sportsmanship, and fair play to the children of the community, so that they may someday use these values in becoming good citizens.

Sponsorship of a sign in the LBA does not permit the Sponsor to have any rights or responsibilities in the operation of the LBA or any team in the LBA, nor does the Sponsor have any rights or responsibilities in the selection of managers, coaches or players for any team in the LBA. Nothing herein shall make us partners or joint venturers. The Sponsor and the LBA are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

The Sponsor shall have the right to use the following term in advertisements, posters, brochures, newsletters, etc.: “Sponsor of a team in the Linwood Baseball Association.” Sponsorship does NOT give the Sponsor the right to use the word “official” in connection with its Sponsorship. Any reference to the Sponsorship under this Agreement must make it clear that the Sponsorship is with the LBA only, and NOT for Little League Baseball and/or Softball. Use of the “keystone logo” or any other logo of Little League Baseball and/or Softball is prohibited, unless permission is expressly granted in writing by Little League International. Sponsorships can be revoked by LBA and/or Little League International at any time without refund for violating any of the policies set forth herein, or for any other violations of this Agreement.

Sign Sponsorship in the LBA carries with it the following additional benefits:

* Sponsor name will be placed on a sign, which sign will be placed on the outfield fence of the Little League field during the active LBA season (and playoffs/tournaments) for the period of sponsorship selected below.

The fee schedule for sign Sponsorship is as follows:

- **Sign to be place on the outfield fence of the Little League field for 1 year:
\$350.00**
- **Sign to be place on the outfield fence of the Little League field for 3 years:
\$700.00**

For the considerations above, the Sponsor selects to be (**select one**): a [___] one-year sign sponsor, or a [___] three-year sponsor, and hereby donates \$_____ to the LBA, and elects to be a sign Sponsor of LBA understanding that its donation is to benefit the entire LBA league and that by doing so, Sponsor has induced LBA to order a custom sign for Sponsor.

Payments of fees to LBA are due at the time this Agreement is signed. The Sponsor hereby acknowledges and agrees that it shall remain responsible and obligated to make the above payments to LBA when due and that such commitment continues until all such amounts are fully paid and satisfied.
