In consideration of being permitted in the activities and programs of the **EAGER BEAVER FOOTBALL CLUB OF BEAVERCREEK**, including, but not limited to football drills, practice and games, cheerleading practice and activities, and fundraising activities, **RELEASOR** for the aforesaid minor child/ren and himself/herself and their person, representatives, heirs, and next of kin, hereby released, waives, discharges and covenants not to sue **EAGER BEAVER FOOTBALL CLUB OF BEAVERCREEK**, its officers and members, all referred to as "**RELEASEES**", from all liability to the **RELEASOR** and his/her minor child/ren, their personal representative assignees, heirs, and next of kin for all loss or damages, and any claim or damages therefore, on account of injury to the person or property resulting in deal of the **RELEASOR**, and/or his/her minor child/ren, whether caused by the negligence of **RELEASEES** or otherwise while the **RELEASOR** and/or his/her child/ren are engaged in any activity and/or program sponsored by the **RELEASEES**.

RELEASOR agrees to indemnify the **RELEASEES** and each of them from any loss, liability, damage or cost **RELEASEES** may incur due to the presence of **RELEASOR** and/or his/her minor child/ren in or on any practice field, football field, or any other place used by the **RELEASEES** in its activities and programs, whether caused by negligence of the **RELEASEES** or otherwise. **RELEASOR** hereby assumes full responsibility for any risk of bodily injury, death, or property damage due to negligence of **RELEASEES** or otherwise while in on any practice field, football field, or any other place used by the **RELEASEES** in its activities and programs, and/or while competing, officiating in, working on for any purpose, participating in any activity sponsored by the **RELEASEES**.

RELEASOR expressly agrees that this release, waiver and indemnity agreement is intended to be used as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of the agreement is held invalid, it is agreed that the balance shall, not withstanding, continue in full legal force and effect.

RELEASOR further states that he/she has carefully read the above release and knows the contents of the release and signs the release on his/her own free act.

RELEASOR further releases the **EAGER BEAVER FOOTBALL CLUB OF BEAVERCREEK** and its officers and members from any claim whatsoever on account of first aid, treatment, or services rendered him/her of the minor child/ren during participation in the activities and programs of the **RELEASEES**.
