## APPLICATION FOR GAMBLING LICENSE

I. The undersigned organization, by a principal officer, hereby makes application for the issuance of a license to conduct the following games in accordance with Title 13, subtitle 15 of the Annotated Code of Maryland.

- (1)  Bingo (to include one day Instant Bingo - valid for 24 consecutive hours) (\$5.00 fee)
- (2)  Members Only Instant Bingo (valid for 3 months) (\$15.00 fee)
- (3)  Bingo & Paddle Wheel (valid for 24 consecutive hours) (\$10.00 fee)
- (4)  Paddle Wheel (valid 24 consecutive hours) (\$10.00 fee)
- (5)  Paddle Wheel in conjunction with and at the location of a carnival (not to exceed 14 consecutive days) (\$10.00 fee)
- (6)  Raffle (valid until drawing(s) on one calendar day) (This includes 50/50 raffles & Quarter Auctions) (\$10.00 fee)

The authorized activities were conducted at the time and place stated in the application by the regular members of the organization personally, without the assistance of professionals, and that the member or members conducting such activities do not regularly conduct any such activities for any other organization.
  - b. No cash prizes were offered except as stated in III (3) of this application.
  - c. The amount and disposition of the cash proceeds of the licensed activities.
