

## **LEHUGHTON ATHLETIC BOOSTER CLUB**

### **WRESTLING RULES**

- 1. AN INSURANCE POLICY MUST BE IN AFFECT FOR ALL PARTICIPANTS.**
- 2. ALL PARTICIPANTS MUST HAVE A PHYSICAL EXAMINATION BY A CERTIFIED DOCTOR PRIOR TO PARTICIPATING IN PRACTICE OR MATCHES.**
- 3. REGISTRATION FEE AND PHYSICAL FORMS ARE DUE AT THE FIRST PRACTICE AND NO LATER THAN THE FIRST WEEK OF PRACTICE.**
- 3a. ANY EQUIPMENT OBLIGATIONS NOT SUFFICED FROM ANY SANCTIONED LABC SPORT WILL MAKE THAT INDIVIDUAL INELIDIGIBLE UNTIL ALL PRIOR SPORT OBLIGATIONS ARE MET.**
- 4. AGE REQUIREMENTS ARE SET BY THE VALLEY ELEMENTARY WRESTLING LEAGUE.**
- 5. ALL PARTICIPANTS MUST PRACTICE FOR ONE FULL WEEK PRIOR TO COMPETING IN MATCHES.**
- 6. ALL WRESTLERS MUST ATTEND THREE FULL PRACTICES IN ORDER TO BE ELIDGIBLE FOR THE WEEK END MATCHES. THIS RULE IS UP TO THE DISCRETION OF THE HEAD COACH, IF HE REQUIRES MORE / LESS ATTENDANCE.**
- 7. NO ONE MAY REGISTER AFTER THE FOURTH MATCH AND BE ELIDIGIBLE TO PARTICIPATE IN THE VALLEY ELEMENTART WRESTLING LEAGUE.**
- 8. NO UNIFORMS SHALL BE HANDED OUT UNTIL ALL REGISTRATION & FUNDRAISING FEES HAVE BEEN SATISFIED.**
- 9. ALL PARENTS MUST SIGN OFF ON ALL EQUIPMENT WHEN RECEIVING AND RETURNING LABC ISSUED EQUIPMENT.**
- 10. ANY EQUIPMENT NOT RETURNED BY THE PROGRAM ISSUED DATE WILL BE SUBJECTED TO A CHARGE FOR REIMBURSEMENT AND /OR ISSUE OF A SUMMONS TO APPEAR AT THE LOCAL MAGISTRATES OFFICE.**
- 11. ALL COACHES ARE SUBJECT TO A BACKGROUND CHECK (ACT 134).**
- 12. ALL DIRECTORS AND HEAD COACHES ARE SUBJECT TO A BACKGROUND CHECK (ACT 134) AND A CHILD ABUSE CLEARANCE.**

**13. DIRECTOR & HEADCOACH HAVE FINAL SAY ON ALL ASSISTANT COACHES AND TEAM MOMS.**

**14. THE HEAD COACH IS RESPONSIBLE FOR THE CONDUCT OF HIMSELF AND HIS STAFF.**

**15. ALL INJURIES MUST BE REPORTED AT ANY LABC SANCTIONED PRACTICE OR EVENT.**

**16. IF A WRESTLER IS INJURED, A SIGNED RELEASE FROM A DOCTOR WILL BE REQUIRED BEFORE RETURNING TO PRACTICE**

**17. ANY COACH DISMISSED FROM A MEET FOR INAPPROPRIATE CONDUCT WILL BE SUSPENDED FOR THE NEXT MEET ALSO.**

**18. ALL PARENTS ARE REQUIRED TO WORK THE FOODSTAND AS PART OF THEIR TEAM OBLIGATION. THE AMOUNT OF TIMES WILL BE DECIDED ON THE AMOUNT OF HOME EVENTS THAT THE PROGRAM HAS ACQUIRED FOR THAT SEASON.**

**19. ANY WRESTLER WITH 3 UNEXCUSED ABSCENES WILL BE CUT FROM THE TEAM.**

**20. ANY CONDUCT REGARDED AS UNSPORTSMANLIKE, ie; THROWING OF HEADGEAR, CURSING DURING A MATCH, ARGUING WITH A COACH, PARENT OR REFEREE, HORSEPLAY WHERE A INJURY HAS RESULTED OR ANY CONDUCT DEEMED DETRIMENTAL TO THE TEAM OR ORGANIZATION WILL CARRY A MINIMUM 1 MATCH SUSPENSION.**

**21. NO WRESTLER MAY PRACTICE OUTSIDE THE ORGANIZATION ON ANY SET NIGHTS PRACTICE. ANYONE CAUGHT PRACTICING OUTSIDE THE TEAM ON A PRACTICE NIGHT WILL BE REMOVED FROM THE SQUAD.**

**22. NO PARENT WILL BE ALLOWED IN THE WRESTLING AREAS(LOCKER ROOM) OR AT THE MAT DURING EVENTS EITHER HOME OR AWAY. ALL PRACTICES WILL BE CLOSED TO ALL PARENTS. ASSISTANTS AND TEAM MOMS ARE THE ONLY PARENTS THAT WILL BE ALLOWED AT A PRACTICE SESSION.**

**23. ANY CIVIL LAW INFRACTION OR CONDUCT BY A PARTICIPANT IN THE LABC WRESTLING PROGRAM THAT IS DETERMINED BY THE HEAD COACH AND / OR EXECUTIVE MEMBER (S) OF THE LABC THAT IS DEEMED DETRIMENTAL TO THE PROGRAM, CLUB OR SCHOOL DISTRICT WILL RESULT IN A IMMEDIATE SUSPENSION /OR DISMISSAL BY THE HEAD COACH.**

**24. ANY NOVICE ENTRANT WHICH FAILS TO ENTER THE YEAR END TOURNAMENT WHICH THE LABC PAYS FOR IS SUBJECTED TO REIMBURSE THE CLUB THE SAID REGISTRATION FEE.**
